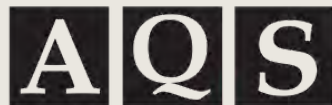

JUSTICE DATO' LEE SWEE SENG
Court of Appeal Judge of Malaysia

Justice Dato' Lee Swee Seng graduated with a Bachelor of Laws (Hons) degree from the University of Malaya and obtained his Master of Laws from the same university. He also holds an MBA degree from the University of Southern Cross, Australia. Justice Dato' Lee was called to the Malayan Bar in February 1985 and was in active legal practice until May 2010, when he was appointed a Judicial Commissioner of the High Court of Malaya. He was made a Judge of the High Court of Malaya in 2014 and elevated to the Court of Appeal on 8 August 2019. Justice Dato' Lee has presented numerous papers and spoken at seminars and conferences on corporate and securities law, intellectual property, construction and adjudication, mediation, contractual disputes and many other topics. He was also a visiting fellow of Taylor University Law School and a part-time lecturer with UM Law Faculty for the LLM Masters Programme. Justice Dato' Lee is a trained advocacy trainer with Bar Council Malaysia for its Advocacy Training Course. He was also the High Court Judge of the Construction Court in Kuala Lumpur from 2016 to August 2019 before his elevation to the Court of Appeal.

Oliver H.C. Wee, the President of Master Builders Association Malaysia (MBAM) has over 40 years of experience in the construction industry and has been actively served with the Association voluntarily since 1994. Since 2022, Wee has been appointed as a Board Member of the Construction Industry Development Board Malaysia and the Board of Directors of Construction Labour Exchange Berhad (CLAB). He was appointed in March 2023 as a Panel of Experts under the Local Government Development Ministry to advise on programmes and policies under the purview of the ministry such as housing, local government, urban sustainability, and solid waste management. He sits on the Advisory Committee for the CIDB Construction Law Report. In the international frontage, Wee is currently the International of Asian & Western Pacific Contractors Association (IFAWPCA) Ambassador to the International Federation of Consulting Engineers (FIDIC) as well as the IFAWPCA Chairman of Conditions of Contracts Committee. He was the Chairman of, the ASEAN Constructors' Federation (ACF) in 2023. In addition to the mentioned portfolios, he was also the Executive President of China ASEAN Construction Industry under the Belt & Road initiative from 2015 to 2016 and was newly appointed as the Committee Member of the RCEP Industrial Cooperation Committee under Council ASEAN Business Council (CABC) in 2023.

Justice Dato' Lim Chong Fong D.S.P.N. has a Bachelor of Science (Building) Honours degree from the National University of Singapore, a Bachelor of Laws Honours degree from the University of London, and a Master of Laws degree from the University of Malaya. He is also a Chartered Arbitrator, Chartered Quantity Surveyor, and Barrister at Law (Middle Temple). He has worked as a quantity surveyor in the construction industry and practiced as a construction lawyer and arbitrator from 1985 to 2013. He was ranked as a leading lawyer in construction dispute resolution by Chambers & Partners, Asialaw Profiles, and The International Who's Who of Construction Lawyers' legal directories. He has undertaken research on the security of construction payment as a Fulbright scholar at the William S. Richardson School of Law in Hawaii, USA, and was subsequently appointed by the Construction Industry Development Board Malaysia to formulate the Construction Industry Payment and Adjudication bill (now Act 746 of Malaysia). He was the Honorary Advisor (Contracts) of the Master Builders Association Malaysia and was appointed by the Minister of Works in 2013 as a member of the expert panel to review the Malaysian construction industry practices following the construction accident at the Penang Second Bridge project. In 2017, he was awarded the Lifetime Achievement Award (Quantity Surveying) by the Royal Institution of Surveyors Malaysia. Justice Dato' Lim Chong Fong was appointed as Judicial Commissioner on 15th January 2014 and confirmed as Judge of the High Court of Malaya on 30th January 2017. He has served the general civil & criminal courts as well as the specialist intellectual property & construction courts. On 17th January 2023, he has been appointed as Court of Appeal Judge and presently serving the Court of Appeal in the Palace of Justice Putrajaya, Malaysia. Recently he has, amongst 19 others, been conferred the CIDB Fellowship Award 2023.

Retired Federal Court Judge of Malaysia

Justice Dato' Mary Lim Thiam Suan read law at the University of Leeds, UK and graduated with an LLB (Hons) degree. She has been admitted to Lincoln's Inn as a Barrister-at-law. In 1993 she obtained her Master of Laws degree from the University of Western Australia. Prior to her elevation to the High Court of Malaya, where she sat in the New Commercial Court, her Ladyship served in various capacities at the Attorney General's Chambers of Malaysia. These include as Federal Counsel, Senior Federal Counsel, Senior Assistant Parliamentary Draftsman, Legal Advisor to the State of Negeri Sembilan, Deputy Head of Civil Division and Commissioner of Law Revision and Law Reform. Justice Lim was the first judge of the Construction Court in Kuala Lumpur until her Ladyship's elevation to the Court of Appeal. She recently retired as a Judge of the Federal Court of Malaysia.

Justice Datuk Wong Kian Kheong graduated with a Bachelor of Laws (First Class Honours) degree from University of Malaya (UM) in 1988. Thereafter he was awarded a scholarship from Cambridge Commonwealth Trust-Shell Group of Companies to pursue his Master of Laws (Honours) degree in University of Cambridge in 1989. He was called to the Malaysian Bar in March 1990. He then joined the Judicial and Legal Service where he served as a Deputy Public Prosecutor (DPP) in the Attorney General's Chambers (AGC) until he commenced private practice in December 1997. Justice Wong had been awarded Excellent Service Award twice when he was a DPP in AGC. He had represented Malaysia in various conferences on, among others, the drafting of the United Nations' Rome Statute of the International Criminal Court, treaties on extradition and mutual legal assistance in criminal matters. He had lectured on a part-time basis in UM's Law Faculty and Brickfields College. Justice Wong was the editor for Mallal's Monthly Digest and Annotated Statutes of Malaysia as well as a case reporter for Malayan Law Journal. He had also served as a Course Outline Reviewer, Examination Question Setter and Examiner for the Certificate in Legal Practice conducted by the Legal Profession Qualifying Board (QB). When he was in practice, he had served as a Chairman of Disciplinary Committee and had acted pro bono for QB, Bar Council and Disciplinary Board. He had also been appointed to act for Bank Negara Malaysia, Selangor State Government, Malaysian Highway Authority, Langkawi Development Authority and UM. Justice Wong was appointed a Judicial Commissioner in June, 2014 and then a Judge in April 2018. Prior to his elevation to the Court of Appeal in January 2023, he was attached to the Shah Alam Construction Court. 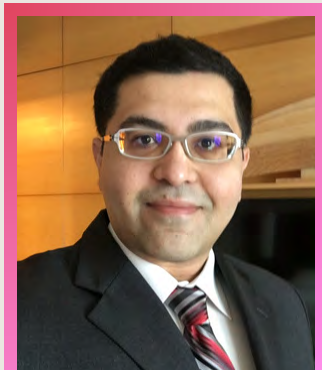

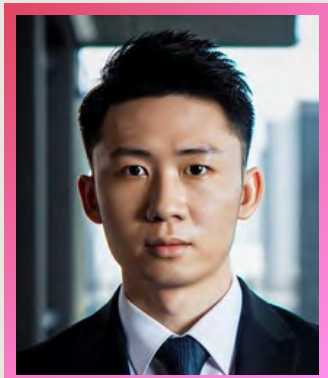

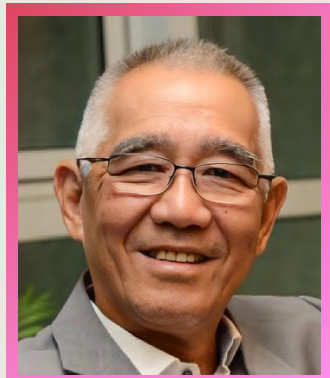


WONG HIN LOONG

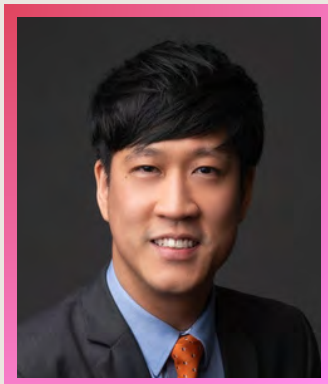


MAY TAI
